JULY SPEAKER SUMMARY

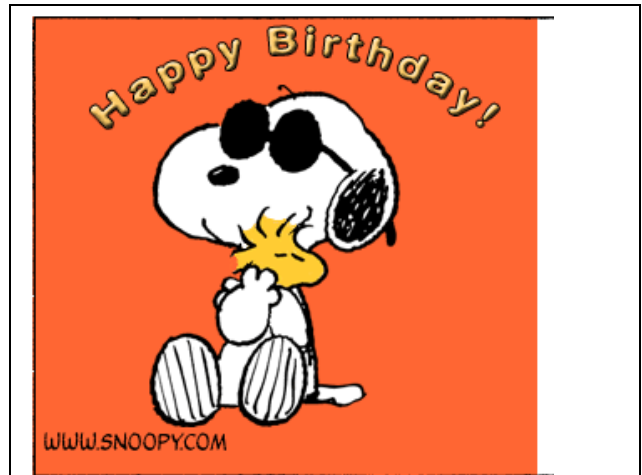
